- o Fees must be paid in full thirty days prior to date of event or may be subject to a late fee of \$50.00. Any changes within thirty days of event will be charged a \$50.00 change fee plus any additional hours requested.
- o Events scheduled Monday through Thursday will receive an additional 10% discount on hourly rate.
- o Certificate of insurance may be required, see insurance policy guidelines.
