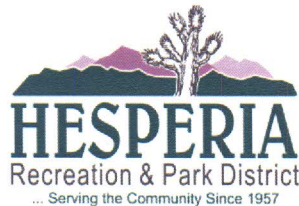


### **MESSAGE TO THE PUBLIC/PUBLIC COMMENT**
