**c. Rick Novack High School Scholarship**

**c. Rick Novack High School Scholarship**

1. Mr. Woolley reported that we are moving forward with the scholarship as planned. Any increases in funding can be worked into the next year's budget.
2. The Board requested to put the the scholarships on the Agenda at the beginning of next year, to discuss the increase in funding and opening the applicant pool to all schools in Hesperia, including charter schools and home school students.
3. Vice Chair Member Blocker expressed the need to increase fundraising if the Foundation would like to increase the scholarship funding.
4. The next Agenda is to include fundraising ideas to complete before the next budget season, as to support the increase in available scholarships.

**d. Preservation Committee Update**

1. Chair Member Drylie reported that the museum got a six camera system.
2. Photos will be taken at the Historical Preservation Committee meeting the following day including the committee and the General Manager. They will then be discussing upcoming projects for 2023.

4. The Harrision Exhibit Center is always looking for donations. They are working toward a drone to enhance the historical videos with arials.

**f. Rodeo Committee Update**

1. Vice Chair Member Blocker requested to have a website for the HARD Foundation and the Hesperia Days Rodeo.
2. Staff explained the expenses involved and suggested options for the time being including making them both more prominate on the Home page of the District website. Marketing strategies will be presented in the coming meetings for the committee to discuss and give input.
3. The Hesperia Days Rodeo Budget and Task List are being built. Final numbers from the 2022 Hesperia Days Rodeo are being finalized.
4. Vice Chair Member Blocker expressed the need for quick decision making when it comes to the rodeo. Mr. Woolley explained the Task List preapproves most necessary decisions, and that the event needs to be approved through the District.

**g. Equestrian Trails**

1. The Board requested to look for more agreements west of Cedar Street and Maple Avenue.
2. Chair Member Drylie commented that the purpose of the item is to be sure that the trails are preserved throughout the Silverwood development. He suggested the granite stone pieces at Hesperia Lake Park could be used to create markers for the trails. He will get with Member Hill to map it.
